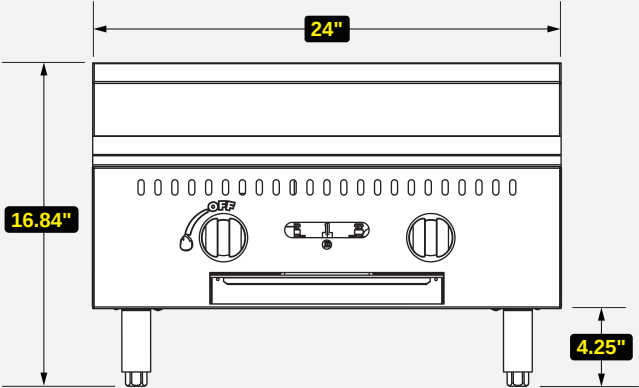

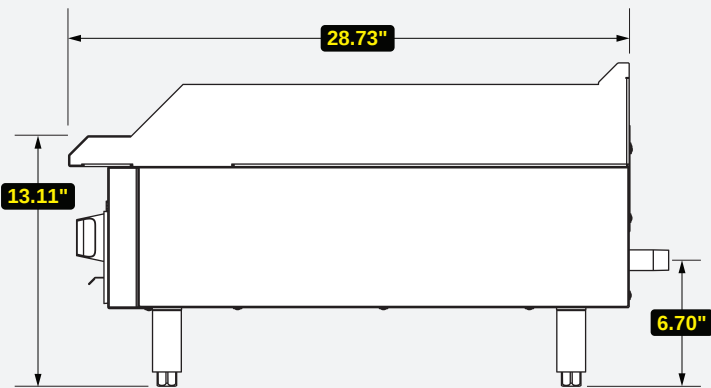

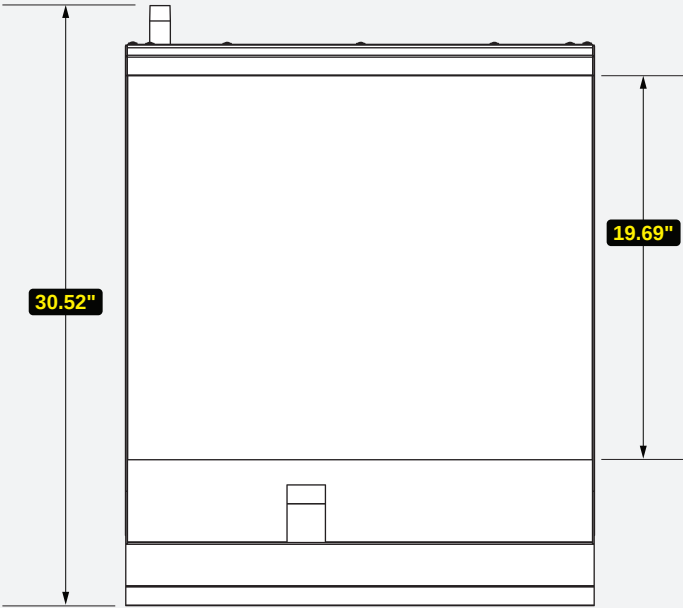

Side View



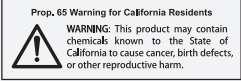

Notify carrier of damage! Inspect all components immediately.
